CONDITIONS:

To Enter and Qualify:

1. Competition is only open to Australian and New Zealand travel consultants who must be employed as such at the time of taking the prize tour.
2. Qualifying tours must be sold within a 12 month period.
3. Qualifying tours are from sales per consultant, not agency total and Kumuka bookings cannot be transferred between consultants.
4. All qualifying bookings must be paid in full before the competition prize tour can be booked.
5. The competition prize tour must be booked and deposit paid within six months of final payment date of the last qualifying booking.
6. Anzac Day tours, Specialist tours and Add-ons must be of a minimum value of AU/NZ\$1,000 per person and will only count towards the competition prize if they are booked independently i.e. not in conjunction with another tour.
7. Travel consultants must provide relevant Kumuka booking numbers to qualify for competition.
8. Segments of larger trips will not be considered as multiple trips.
9. Passengers booked on Family Adventure paying adult price will qualify towards the incentive. Passengers booked at child prices will not count towards the competition.
10. Tailor Made bookings with a value of more than AU/NZ\$3,000 per passenger can qualify for this incentive to a maximum of four credits per Tailor Made booking.

In the event that for any reason whatsoever a winner does not take an element of the prize at the time stipulated by the promoter then that element of the prize will be forfeited by the winner and cash will not be awarded in lieu of that element of the prize.
17. The promoter reserves the right to substitute any component of the prize for a tour of equal value at their discretion.
18. Tours cannot be gifted to other persons in lieu of the winner not being able to travel. Should the winner not be able to complete all tours within the period of prize validity, the remaining tours shall be forfeited without any replacement for their value. Prize winners will be required to agree to and sign to Kumuka's booking conditions when booking tour otherwise prize will be forfeited.

Prize

1. This is a contest of skill. Winner will be chosen on creativity and merit of written component by a panel of judges from Kumuka Worldwide. The closing date for the promotion is 31 December 2011 at 00:00 (AEST). The competition judging will take place at 12:00 (GMT) on 09 January 2012 at Kumuka Global Head Office at 40 Earls Court Road in London. The winner will be notified by e-mail within five days of the judging taking place.
2. Depending on number of entries, Kumuka reserves the right to increase the number of winners at its own discretion.
